Trophies entered into the WI Whitetail and WI Black Bear categories will be judged on SCI score. All other will be judged on the One-Shot Rule. That is to say, if you had only one shot, and that shot was for either a Stone Sheep or a Black Bear entered in the North American category, which would you choose? Judging is based upon which animal is thought best to represent the category entered. The animal will not be judged on its SCI score, nor on the quality of the taxidermy work.

> Entry fee is \$20 per animal which includes SCI scoring and admission to the Expo. There is no limit to the number of trophies you may enter.

Hunters entering trophies in the Trophy Competition will need to have their trophies at the Wisconsin State Hunting and Fishing Expo at the Resch Expo in Green Bay, WI on Friday thru Sunday noon. Trophy judging will be done on Sunday between noon and 2:00pm. Judges' evaluations are final. Trophies can be removed from show between 3:00 - 5:00 on Sunday, after the judging has been completed.
